## RE: Proposed Legal Action - Against the US Forest Service - Degradation of Lake Tahoe Waters

#### Lake Tahoe Waters

Lake Tahoe waters are labeled as an "Outstanding National Resource Water" under the US Clean Water Act.

However, 84,092 acres of protected Lake Tahoe waters, Trout Creek, Ward Creek, and 61+ miles of the upper and lower Truckee River are classified as **impaired** waters under the Clean Water Act due to the adverse impacts of **phosphorus and nitrogen**.

## U.S. Forest Service (USFS) Intentional Wildland Fire Growth Policy

Widely unknown to the public, and since 1978, the US Forest Service has incrementally implemented a 43-year-old policy option of intentional forest fire growth. This practice is often referred to as "managed" wildfire **or** "WFU" (wildfire use). The incremental implementation of this policy has now grown to catastrophic proportions. What began as a USFS limited policy option, has grown into an out-of-control practice of intentional forest fire growth. This then, resulting in significant and adverse environmental impacts on our Sierra range resources including, our forests, wildlife, and cherished Lake Tahoe region waters.

Here in Lake Tahoe, toxic smoke from ongoing, epic USFS "managed" Sierra range forest fires, since 1978, have cumulatively and adversely impacted our protected alpine waters by depositing forest fire burn smoke bi products, including **phosphorus**, **nitrogen**, **and carbon black** directly on and into the impaired waters of Lake Tahoe. This, in violation of the National Environmental Policy Act (NEPA), which requires an environmental review of this practice, which has not been performed by the USFS.

Over the last three years, the Lake Tahoe region has been described as having the worst air quality on the planet as a result of these massive pollution events.

# Litigation

TahoeCleanAir.org asserts that the US Forest Service has violated the National Environmental Policy Act (NEPA) by depositing significant and adverse amounts of phosphorus and nitrogen into 84,092 acres of "impaired" Lake Tahoe waters, including Trout and Ward Creeks plus 61+ miles of the upper and lower Truckee River without conducting the required environmental review.

In light of more recent substantive information, including but not limited to the University of Nevada at Reno and the 2022 UC Davis "State of the Lake" reports, TahoeCleanAir.org intends to enjoin the U.S. Forest Service in connection with their intentional forest fire growth policy and require an immediate environmental review of the effects of this policy on the impaired waters of the Lake Tahoe region.
